

### Investment focus

The fund's aim is to achieve capital growth in the long term. The Fund invests in listed owner-controlled companies in Europe where an entrepreneur or a founding family holds at least a stake of 20% of the company's voting rights. The typical qualities of these companies – a focused business model, fast decision-making processes, sustainable business policies and a strong corporate culture – go hand in hand with efficient innovation, high product quality and strong customer loyalty. The fund's Management Team offers a wealth of experience in this investment segment and has built up an extensive network with executives throughout the sector. It pursues a fundamental, bottom-up approach in identifying the most attractive founder-controlled companies with a mid as well as large market capitalization while maintaining an investment portfolio of 30 to 40 stocks diversified by country and subsector.

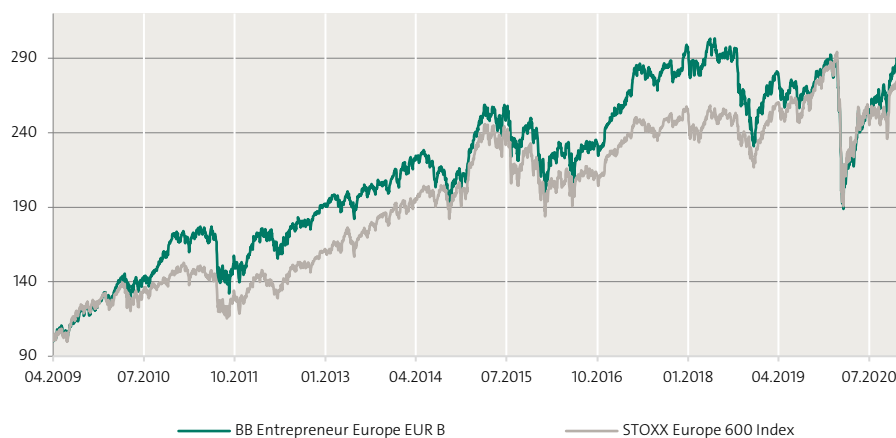

### Indexed performance since launch



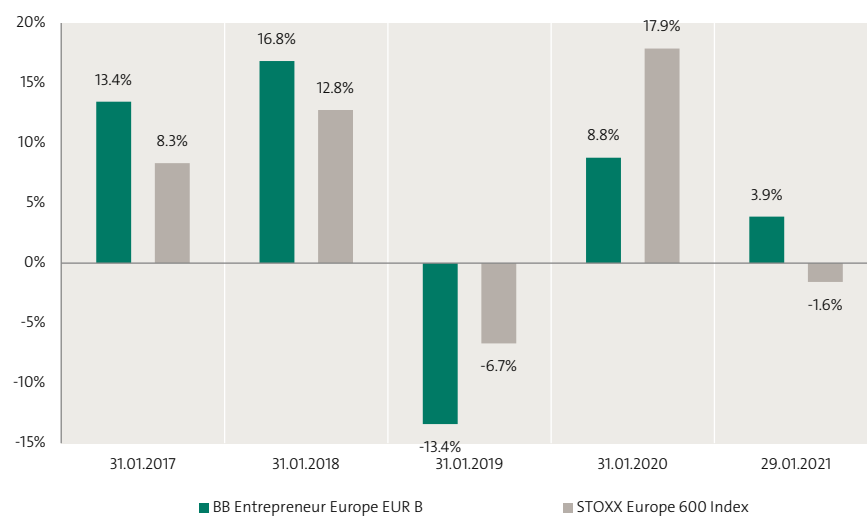

## Market review

European equities, as measured by the SXXR, were down 0.8% in January. The positive economic outlook for 2021 has been overshadowed by continued rising COVID-19 cases, extended lockdowns, the emergence of new variants as well as delays in the initial vaccination program due to production bottlenecks. This makes for a soft start with Q1 2021 Eurozone GDP forecast slowing to -2.5%, and a subsequent +12.6% yoy rebound expected for Q2. Composite PMI were down from 49.1 in December to 47.5 in January, still largely above levels seen during the initial months of the pandemic, suggesting that the economic impact of the second wave has so far been considerably less severe. The greatest signs of resilience continued to be evident in manufacturing as Eurozone factory output expanded for a seventh consecutive month thanks to sustained growth of new orders and exports. Sector wise, telecom (+3.3%), technology (+3.3%) and basic resources (+2.4%) performed best, while insurance (-5.1%), consumer product & services (-4.3%) and travel & leisure (-1.9%) lagged the most.

Against this backdrop, the fund declined 0.4% (EUR / B shares), outperforming its benchmark by 40 bps. Main detractors in the month were Worldline (-11.4%), Subsea 7 (-7.7%) and Crédit Agricole (-9.1%). The electronic payment specialist Worldline suffered from the renewed lockdowns across Europe prompting consensus downgrades and delaying its return to trend growth. With consensus estimates now derisked and valuation approaching the bottom 3 year-range, Worldline's risk/reward looks attractive again, underpinned by the secular switch to non-cash payment as well as ongoing sector consolidation. Subsea 7 consolidated after its strong rebound in late 2020. The stock remains together with Lundin Energy our top pick in the Energy sector. We see a multitude of triggers for Subsea 7 from a cyclical improvement and stronger cash flow generation to the potential revaluation or spin-off of its renewables activities. Crédit Agricole consolidated overproportionally after a 52% rally in the November/December value rebound. The sector remains attractive in view of the expected economic and reflation scenario. With a ROTE of 9% versus P/TBV of 0.75x we deem the stock attractive. Also the strong capital base should allow for attractive dividend yields.

Top 3 contributors in the month were ASM International (+17.4%), Inpost (+23.8%) and SKF (+6.7%). ASM International benefited from excellent news flow on the capex front, reinforcing the idea that the semiconductor sector finds itself in a very positive structural LT trend. TSMC, the largest and most advanced semiconductor foundry, guided for 2021 investments to be up a massive 50%, an acceleration motivated by the need to keep improving the performance of its most advanced products as well as the strong demand. In parallel, Intel confirmed its intention to remain a semi manufacturer until 2023 at least, while Samsung is considering a USD 10 bn investment in a new US plant. We participated in the Dutch IPO of Inpost, a leading e-commerce enablement platform. The company provides delivery services through a network of automated parcel machines (APMs) and is one of the most compelling options to solve the challenge of last mile logistics for the years to come. We like the business concept, which has a strong appeal for merchants (20-25% cheaper vs "door delivery"), environmental benefits (66% lower CO2 footprint), strong customer satisfaction and good economics. Inpost boasts strong barriers to entry, a scalable business model as well as a very strong cash conversion. The international ball baring company SKF performed along other cyclicals in anticipation of a strong Q4 delivery. Thanks to its successful restructuring we believe SKF is in a good position to finally reap the fruits of years of cost optimization, amplified by a cyclical recovery of its revenues.

## Positioning & outlook

Markets have performed well ahead of earnings in 2020 and in 2021 we therefore need evidence of strong EPS delivery. In a likely scenario of synchronized worldwide growth from H2 2021 on, cyclical stocks should benefit the most, widely outgrowing their defensive peers. As a region, Europe is expected to stage the sharpest rebound as it suffered the steepest fall and boasts the more cyclical bias in terms of index composition. We deem this a positive environment for value, cyclicals and small and mid caps similar to the years 2016/17. We have added to our value exposure now accounting for ca. 1/3 of the BB Entrepreneur Europe Fund, our latest addition being Swatch Group.

It is therefore particularly suited to investors with an investment horizon of at least 5 years who want to enhance their portfolio diversification with investments in European founder-controlled companies.
